SCHOLARSHIP ANNOUNCED BY PASSAIC COUNTY BAR FOUNDATION PATERSON, NJ

THE HONORABLE NICHOLAS G. MANDAK MEMORIAL SCHOLARSHIP

The Honorable Nicholas G. Mandak was a Judge of the Superior Court of Passaic County and the Assignment Judge until his untimely death in 1996. His achievements and contributions to jurisprudence in this State have been recognized by the establishment, by the Passaic County Bar Foundation, of the Honorable Nicholas G. Mandak Scholarship Fund to assist young people to further their education in the law and allied fields. The scholarship provides grants of \$500.00 - \$1,000.00 annually to deserving persons.

The Honorable Nicholas G. Mandak Memorial Scholarship is open to any student residing in Passaic County, aspiring to attend a university, college or other post-secondary education program to undertake a course of study in the law, criminal justice, paralegal education and courses for Police or Sheriff's officers. In addition, eligible students may not have already been receiving or awarded a full tuition scholarship or waiver of tuition or fees from another source.

The criteria for the scholarship is to complete an application demonstrating need, together with any additional information which addresses any special needs or circumstances which you believe should be brought to the attention of the Foundation, as well as two letters of recommendation. High school transcripts, scholastic records, school activities and extracurricular activities will also be considered.

The scholarship is open to future and current students and must be received no later than Friday, February 17, 2023.
